Explanation for the increase in profit after corporate tax in 2024 by VND 98,5 billion, equivalent to a 335% increase compared to 2023:

The increase was primarily driven by the real estate transfer activities at Dai Dong – Hoan Son Industrial Park, Bac Ninh Province, conducted by the Bac Ninh Branch. In 2024, the legal procedures for Phase 2 implementation were completed, enabling revenue recognition. This resulted in a revenue increase of VND 583,8 billion (up 128% year-on-year) and a gross profit increase of VND 267,2 billion (up 116% year-on-year). The performance underscores the strong revenue and profit potential of this business segment in 2025.





- In addition, financial income increased by VND 31,6 billion (up 300% year-on-year), mainly attributable to profit-sharing from investment cooperation at the parent company and interest income from deposits and lending activities at both the parent company and the Bac Ninh Branch.

As a result, profit before tax increased by VND 150,6 billion (243%), and profit after corporate tax increased by VND 98,5 billion (335%) compared to 2023.

The reasons explained in the Separate Financial Statements as mentioned above also serve as the basis for the changes in profit presented in the Consolidated Financial Statements for 2024:

- Revenue in 2024 increased by VND 534,2 billion, equivalent to a 41% rise, while gross profit increased by VND 249 billion, equivalent to a 96% rise compared to 2023.
- Profit before tax in 2024 increased by VND 141,6 billion (up 182%), and profit after corporate tax increased by VND 84,6 billion (up 198%) compared to 2023.

2. Explanation for the change in profit after corporate tax in the Separate and Consolidated Financial Statements for 2024 before and after audit of 5% or more
